"Disability accessibility is not a question of just physical accessibility alone. People think ramp construction is enough but they need to understand that this alone does not address the problem. There are gradient components to it too, at times it is very steep so the ratio of the ramp has to be kept in mind," he said. Every disability has its own requirement. A person with visual disability has a different kind requirement than a person with hearing impairment. Accessible toilets are also needed, just a western commode is not enough, Muralidharan said. Arman Ali, executive director at the National Centre for Promotion of Employment for Disabled People, too said accessibility cannot merely transcend to building ramps. "The need of the hour is to make accessibility for disabled persons a universal concept, not just on paper but in actuality. The Parliament building for instance needs to be accessible to all persons with disabilities. Disability doesn't solely come in the form of a wheelchair user. But in all forms, it also requires other accessibility needs, access to information in all accessible formats." he said. Ali suggested the usage of large prints and sign language interpretation

accessibility should not be limited to a particular row for ease of mobility but the entire House, including the Speaker's chair. India is at the forefront of cultural and economic growth. However, what is lacking is the representation of disabled people in the political arena.
